- Strong financial position

4.2 Financials update - Navaz

- Previous Fiscal Year Financial Statements submitted
- Cash position of about \$150k (\$40k of casino revenue is in reserve and can't be used yet)
- Big revenue earners are casino (\$70k to \$80k now) every 18-24 months and M&M event (\$50k earnings after expenses)
- Statements will be available in the binder in the office for parents to view anytime (noted these are not publicly available on the school website)
- \$250-\$260 per kid every year spent (need around \$60,000 per year to keep things floating)
- Note that society keeps reserves for a two-year period ongoing
- Big project likely coming at playground fundraising in next 3 to 4 years
- Casino date will be in a year Q4 2025
- Jason facility upgrade and concept for a school initiative time capsule project for centennial (next September)
