

#### MEMBERSHIP



2. Any member wishing to withdraw from membership may do so upon a notice in writing to the Board through its Secretary. If any member is in arrears for fees or assessments for any year, such member shall be automatically suspended at the expiration of six months from the end of such year and shall thereafter be entitled to no membership privileges or powers in the Society until reinstated. Any member upon a two-thirds vote of all members of the Society in good standing may be expelled from membership for any cause which the Society may deem reasonable.

#### PRESIDENT

The President shall be ex-officio a member of all Committees. He shall, when present, preside at all meetings of the Society and of the Board. In his absence the Vice-President shall preside at any such meetings, and in the absence of both a chairman may be elected by the meeting to preside thereat.

#### **BOARD OF DIRECTORS**

- Board of Directors, Executive Committee or Board, shall mean the Board of Directors of the Society.
- The Board shall, subject to the by-laws or directions given it by majority vote at any meeting properly called and constituted, have full control and management of the affairs of the Society, and meetings of the Board shall be held as often as may be required, but at least once every three months, and shall be called by the President. A special meeting may be called on the instructions of any two members thereof provided they request the President in writing to call such meeting, and state the business to be brought before the meeting. Meetings of the Board shall be called by ten days notice in writing mailed to each member or by three

days notice by telegram or telephone. Any four members shall constitute a quorum, and meetings shall be held without notice if a quorum of the Board is present, provided, however, that any business transactions at such meeting shall be ratified at the next regularly called meeting of the Board; otherwise they shall be null and void.

#### SECRETARY



#### **MEMBERSHIP**

SPECIAL RESOLUTION of the Members of the Elbow Park Parent Society (the "Society") passed effective the 7th day of May, 1992 by the consent of all of the Members in writing pursuant to the Societies Act.

BE IT RESOLVED as a Special Resolution that the by-laws of the

Society be amended as follows:

CD:

- 1. By the deletion of item 1 of the By-laws and the substitution of the following:
  - "1. Membership fees, if any, in the Society shall be determined, from time to time, by the Board. Any person, who is a member of the Parents Council of Elbow Park Elementary School in Calgary, Alberta shall be a member of the Society, upon payment of the fee, if any, as may be set by the Board from time to time."
- 2. By the deletion of item 12 of the By-laws and the substitution of the following:
  - "12. Meetings of the Society may be called at any time by the Secretary upon the instructions of the President or Board by notice in writing published in the monthly newsletter of Elbow Park Elementary School distributed not less than three days previous to the date of such meeting or, by mail to the last known address of each member sent not less than 5 days previous to the date of such meeting. A special meeting shall be called by the President or Secretary upon receipt by him of a petition signed by one-third of the members in good standing, setting forth the reasons for calling such meeting, such notice to be given as set forth above."

- 3. By the addition after clause 17 of the items 18 through 23 as follows:
  - "18. The Society shall devote all its resources to its objects, which objects are as stated in its application pursuant to Section 5 of the Societies Act.
  - 19. The Society is not to be carried on for profit.
  - 20. The Society, in devoting its resources to its objects:
    - a. may carry on a "related business" as that term is defined in paragraph 149.1(1)(j) of the Income Tax Act (Canada);
    - b. shall not disburse more than 50% of its income for a taxation year to "qualified donees" as that term is defined in paragraph 149.1(1)(h) of the *Income Tax Act* (Canada);
    - c. may disburse its income to a registered charity that the Minister of National Revenue has designated in writing as a charity associated with it.
  - 21. For each taxation year, the Society, in devoting its resources to its objects, shall expend on those activities described in paragraph 18 above, at least 80% of all donations received in the immediately preceding taxation year for which the Society issued a tax receipt described in subsection 110.1(1)(a) or 118.1(1)(a) of the *Income Tax Act* (Canada), other than gifts of capital received by way of bequest or

inheritance, gifts received subject to a trust or direction that the gift be held for at least 10 years, and a gift received from a registered charity.

- 22. No part of the income of the Society shall be payable to, or otherwise available for, the personal benefit of any member of the Society.
- 23. The Society shall not accept contributions of capital from any person or group of persons (excluding Her Majesty in right of Canada or a province, a municipality, another registered charity that is not a private foundation, or any club, society or association described in paragraph 149(1)(1) of the *Income Tax Act* (Canada)) not dealing with each other at arm's length (as that term is defined in Section 251 of the Income Tax Act (Canada)) if such contributions of capital would constitute more than 50% of total capital contributions to the Society from all sources during the lifetime of the Society."






